## **2026 PHOTO I.D. RENEWAL**

**ON MONDAY, JANUARY 5<sup>TH</sup>, WE WILL BEGIN DISTRIBUTING THE 2026 STICKERS FOR THIS YEAR. YOU MUST BE UP TO DATE WITH HOA FEES IN ORDER TO UPDATE YOUR PHOTO I.D. CARD.**

**YOU WILL BE ELIGIBLE FOR A NEW CARD ONLY IF YOU HAVE THREE (3) OR MORE STICKERS ON THE BACK OF YOUR CARD (NOT COUNTING THE GOLD STAR). THEN SEND A "SELFIE" TO:**

**[TNCFACILITIES@OPTONLINE.NET](mailto:TNCFACILITIES@OPTONLINE.NET). YOUR PHOTO SHOULD BE TAKEN FROM THE SHOULDERS UP, AGAINST A BLANK BACKGROUND. IN THE E-MAIL, PLEASE INCLUDE YOUR FULL NAME, UNIT # AND PHONE #. ONCE WE RECEIVE YOUR INFORMATION AND IT HAS BEEN INPUTTED INTO OUR SYSTEM, WE WILL NOTIFY YOU THAT YOUR NEW CARD IS READY FOR PICK-UP. IT IS ESSENTIAL THAT YOU PRESENT TWO (2) FORMS OF PROOF OF RESIDENCY AT TIME OF PICK-UP. THE ACCEPTABLE DOCUMENTS ARE YOUR OLD PHOTO I.D. CARD AND A "CURRENT" UTILITY/CABLE BILL, BANK STATEMENT OR CREDIT CARD BILL DISPLAYING YOUR NAME AND ADDRESS. MAGAZINE SUBSCRIPTIONS ARE NOT ACCEPTABLE FORMS OF PROOF OF RESIDENCY. (NEW RESIDENTS OBTAINING THEIR PHOTO I.D. FOR THE FIRST TIME, MUST PROVIDE THEIR DRIVER'S LICENSE AS WELL AS A CURRENT BILL OR MORTGAGE).**

**DO NOT SEND US A "SELFIE" IF YOU ARE ELIGIBLE FOR THE "2026 STICKER." (YOU MUST HAVE LESS THAN 3 STICKERS ON THE BACK OF YOUR CARD TO BE ELIGIBLE.) YOU WILL ONLY NEED TO PRODUCE YOUR OLD PHOTO I.D. CARD AND YOUR CURRENT PROOF OF RESIDENCY IN ORDER TO RECEIVE THE 2026 STICKER.**

**2026 PHOTO I.D. RENEWAL - CONT'D.**

**RESIDENTS 16 – 17 YEARS OF AGE MUST BRING IN THEIR SCHOOL PICTURE I.D. AND PARENT'S CURRENT UTILITY BILL DISPLAYING THEIR TOWN 'N COUNTRY ADDRESS. (16 YEAR OLDS MUST BRING IN PROOF OF AGE).**

**TO AVOID MASS CONFUSION AND THE OVERWHELMING OF OUR STAFF, PLEASE DO NOT WAIT UNTIL THE MONTH OF MAY OR OPENING DAY OF THE OUTDOOR POOL (WHICH IS USUALLY MEMORIAL DAY WEEKEND) TO RENEW YOUR PHOTO I.D. CARD.**

**WE WOULD GREATLY APPRECIATE IT IF RESIDENTS WOULD RENEW THEIR PHOTO I.D. CARDS ANY TIME BETWEEN JANUARY AND APRIL.**

**PLEASE KEEP YOUR PHOTO I.D. CARD IN A SAFE PLACE AS YOU WILL BE REQUIRED TO PRODUCE IT WHEN UPDATING YOUR CARD FOR THE NEW YEAR, AND YOU WILL NEED IT TO ACCESS THE FACILITIES.**

**TO REPLACE A LOST/STOLEN CARD, A FEE OF \$10.00  
WILL BE IMPOSED.**
